

Waddi Wind Farm

Fact Sheet December 2023

Community ConsultationFact Sheet



The Waddi Wind Farm is located 150 km north of Perth in the Shire of Dandaragan.

The Waddi Wind Farm project is well known to the community and key stakeholders and was granted conditional planning approval for up to 57 turbines by the Shire of Dandaragan on 11 January 2012. In September 2016 an amendment to the planning approval was granted for changes to the project layout.

In February 2019 an amendment to the planning approval was further granted to increase the turbine tip height from 165m to 180m and to extend the life of the planning approval. The proposed amendments and technological advancements have allowed for a reduction of maximum wind turbines from 57 to 18.

First nations engagement

Preliminary consultation commenced with Yued Traditional Owners (TOs) in 2008 as part of the original Project. Since then, consultation has continued with Yued TOs, and is now undertaken through the newly incorporated Yued Aboriginal Corporation. Ethnographic surveys were undertaken in 2012 and again in 2016 as part of the Planning Approval amendment. To reflect the current Project, further ethnographic surveys were undertaken


with Yued TOs in February 2022, with no new sites or Aboriginal heritage places identified.

In May 2023, a meeting was held with the Aboriginal and Torres Strait Islander Wellbeing and Resilience Coordinator for Amity Health in Moora, to better understand the benefit sharing opportunities within the region and ways to engage. As a result Tilt Renewables' is now providing support for Moora Yued Community Certificate 3 Civil Construction Plant Operations participants and the Yued Baby Splash & Mums Aquafit pilot project.

Aboriginal heritage

A Cultural Heritage Management Plan (CHMP) was subsequently prepared and endorsed by the South West Aboriginal Land and Sea Council in 2016. Tilt began updating the endorsed CHMP to reflect the current project and amendments to the Aboriginal Cultural Heritage Act 2021 (ACH Act).

Tilt Renewables' will ensure the updated CHMP meets our heritage responsibilities under the amended version of the Aboriginal Heritage Act 1972. We will continue to engage with the Yued Aboriginal Corporation and the South West Aboriginal Land and Sea Council in line with amendments to the legislation.



Benefit sharing plan

The benefit sharing plan is still being developed. Potential benefit sharing opportunities being considered include educational, environmental, cultural and health initiatives.
