You will work closely with the Tech team troubleshoot issues, implement security measures, and optimise performance. The ideal candidate is an expert in Azure, a PowerShell guru and considers automation-first. You will have exceptional problem-solving skills, capable of juggling competing priorities, and have a deep knowledge of a wide range of technologies.

- Install, configure, test, and maintain operating systems, application software, and system management tools.
- Proactively ensure the highest levels of systems and infrastructure availability
- Monitor and test application performance for potential bottlenecks, identify workable solutions, and work with developers to implement those fixes.
- Maintain security, backup, and redundancy strategies.
- Write and maintain custom scripts (PowerShell) to increase system efficiency and lower the human intervention time on any tasks.
- Participate in the design of information and operational support systems.
- Provide escalation support to the Service Desk
- Manage and maintain Azure cloud infrastructure, including virtual machines, storage, and networking.
- Maintain MS SQL databases (Azure PaaS and Azure VM - managed)
- Implement and manage Azure security and compliance controls.
- Monitor and optimize Azure infrastructure for performance and cost efficiency.
- Ensure the smooth development of new applications.
- Update technical documentation.
- Maintain systems reliability based on agreed metrics and SLA's
